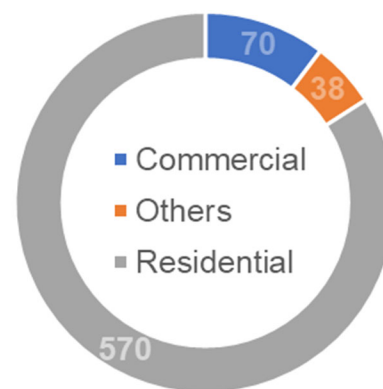

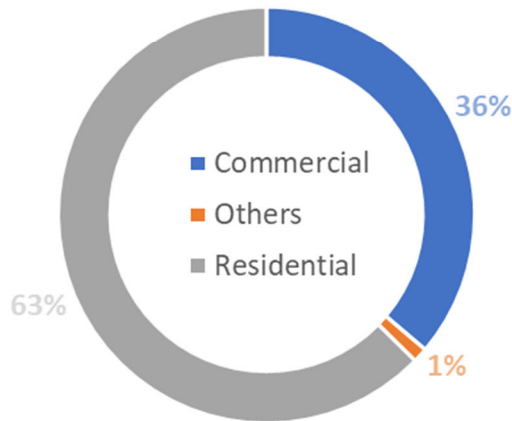
November 2018 Project valuation



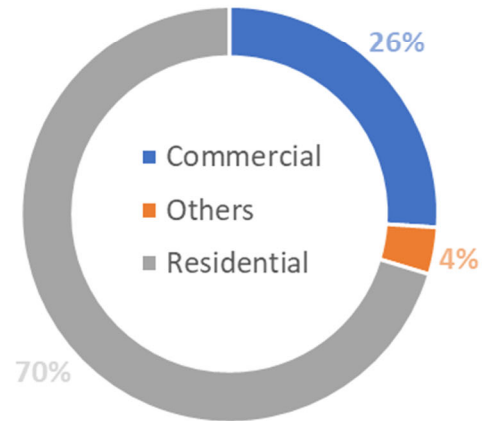
November 2019 Project valuation

The November meeting for the South Mesquite Design Review Board was held on Wednesday, November 6, 2019. Three cases were listed on the agenda and were approved. Synopsis of the cases is included below:

<b>19DR0500124</b>	The rehabilitation of the existing attached residential structures and existing accessory structure located at 233 and 233 ½ S. San Pedro Street.
