**Notice of Funding Availability (NOFA)
Request for Proposal (RFP) Applications
For the City of Las Cruces (City) Program Year (PY) 2019
Community Development Block Grant (CDBG)
Home Investment Partnership Program (HOME)**

The City is announcing the start of the application cycles for PY 2019 CDBG and HOME programs. These Federally-funded programs are used by the City to provide decent housing, a suitable living environment, and the expansion of economic opportunities principally for persons and families with low-incomes. The City anticipates receiving the following grant amounts from the U.S. Department of Housing and Urban Development (HUD) for the PY 2019: CDBG \$869,294 and HOME \$439,502.

In order for an activity or project to receive consideration for application, an RFP-Letter of Intent (LOI) must be completed by the non-profit organization or sponsoring agency and submitted to the Community Development Department, Community Improvement section no later than Thursday, November 1, 2018, 4:30 p.m.

PY 2019 RFP-LOI will be available Monday, October 22, 2018.

The LOI for PY 2019 will be available at www.las-cruces.org. Paper copies of the LOI can also be obtained through email at fairhousing@las-cruces.org or by calling 575-528-3022. CDBG and HOME applications will only be accepted from eligible 501(c)(3) non-profit organizations, government entities, and qualifying grantees.

The City is required to prepare and submit to HUD a One Year Action Plan that provides detailed information on the activities that the City will fund with CDBG and HOME funds for the PY 2019. The City will conduct a public hearing on the proposed One Year Action Plan during March/April 2019. City Council will approve the final One Year Action Plan in May 2019.
